Organizational Meeting April 26, 2017

The organizational meeting was called to order by President Pro-Tem Landeck at 7:08 p.m. with members: Clifton, Dowden, Hall, Hunt, McQueen, Percy, and Walsh present. Also present were Sec Pro-Tem Clapp, Eric Butler, and Duane McKinney.

Landeck recognized the board members elected in the April 4, 2017 board of education election; Hall, Hunt, and McQueen.

Landeck administered the oath of office to Hall, Hunt, and McQueen.

Landeck opened the floor for nomination for the office of President. Percy nominated Dowden and he accepted the nomination. Dowden nominated McQueen and he accepted the nomination. Landeck then closed the floor for nominations. Clapp then took a roll call vote for the office of President with the members voting as follows; Clifton – Dowden, Dowden – McQueen, Hall – McQueen, Hunt – Dowden, McQueen – Dowden, Percy – Dowden, Walsh – McQueen. Dowden was elected President of the Board of Education by a 4-3 vote over McQueen.


Dowden opened the floor for nominations for the office of Vice-President. Hall nominated McQueen and he accepted the nomination. Dowden closed the floor for nominations. As there was only one nominee, Clapp took a voice vote. McQueen was elected Vic-President of the Board of Education by a 7-0 vote.

Dowden opened the floor for nominations for the office of Secretary. McQueen nominated Clifton and she accepted the nomination. Dowden closed the floor for nominations. As there was only one nominee, Clapp took a voice vote. Clifton was elected Secretary of the Board of Education by a 7-0 vote.


