Special Meeting for the Purpose of Student Discipline

The Board of Education of Oakland Community Unit District #5 of Coles, Douglas, and Edgar Counties convened for a special meeting in Room 116 of Lake Crest Elementary School at 9:00 a.m. on April 3, 2015.

The meeting was called to order by President McKinney at 9:06 a.m. with members: Butler, Hudson, McKinney, and McQueen present. Clifton, Dague, and Percy were absent. Also present were Supt. Landeck, Principal Adam Clapp, Principal Patty Stark, and Jack Sanders.

A motion was made by Butler, seconded by McQueen to approve the Agenda as presented. Upon roll, all members present voted aye. Motion carried.

McKinney indicated that a Board member had to be appointed to reside over the expulsion hearing. A motion was made by Hudson, seconded by McQueen to appoint Duane McKinney, Board President, to reside over the expulsion review hearing. Upon roll, all members present voted aye. Motion carried.

A motion was made by McKinney, seconded by Hudson to enter into executive session at 9:08 a.m. Upon voice vote, all members present voted aye. Motion carried.

While the Board was in executive session, student 745220297 and their parent entered at approximately 9:18 am.

The board left executive session and returned to the regular meeting at 9:26 am.

A motion was made by McKinney, seconded by Hudson that student #745220297 be found to have violated school rules by entering the school outside of school hours and causing physical damage to the building as well as stealing personal property from within the building. Said conduct constitutes gross obedience and misconduct and is so related to the school program so as to warrant discipline. Upon roll, all members present voted aye. Motion carried.

A motion was made by McQueen, seconded by Butler to reconvene into executive session at 9:29 am. Upon roll, all members present voted aye. Motion carried.


The board left executive session and returned to the regular meeting at 9:45 am.

A motions was made by Butler, seconded by McKinney to accept executive session minutes as read in executive session. Upon roll, all members present voted aye. Motion carried.


